The certification remains valid until the expiration dates listed, unless we suspend, withdraw, or terminate it. Only the manufacturer of the MSD may apply for this certification to be renewed by writing to the Marine Safety Center (MSC) before it expires. If the MSD is no longer produced, the MSD continues to be considered certified based on the date of manufacture, the vessel installation date, and a valid certification for that time period. You cannot transfer this

approval to another manufacturer without written authorization from the MSC. You must notify the MSC in writing of any proposed changes to the design or construction of these devices.
